### CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** DOYLE H. ALLBAUGH

of 385 Moyer Lane, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of South Yamhill River for the purpose of irrigation of 27.4 acres under Permit No. 18028 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 28, 1947.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.34 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Blair DLC #41, Section 17, Township 6 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 4.8 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$
- 21.4 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$
- Section 16
- 0.4 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$
- 0.8 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$
- Section 17

All as projected within T.R. Blair DLC #41 Township 6 South, Range 6 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at an iron pipe 12.5 chs. S. and 33.42 chs. W. from the NE cor. of Thomas R. Blair Donation Land Claim #41; running th. S. 5° 54' W. 10.70 chs. to an iron pipe in the center of the County Road; th. S. 14° 7' E. 2.77 chs. to an iron pipe in the center of the County Road; th. W. 28.90 chs. to a stake on the bank of Mill Creek, th. N. 13.32 chs.; th. E. 29.33 chs. to place of beginning, containing 38.61 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
