CERTIFICATE OF WATER RIGHT

This Is to Certify, That **FRANK GRIFFITH**

of Box 233, Bly, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Devil's Lake Reservoir constructed under Appl. No. R-27427, Per. No. R-1613 a tributary of Fish Hole Creek for the purpose of primary irrigation of 5.1 acres and supplemental irrigation of 68.4 acres under Permit No. 22900 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 8, 1953,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 76.6 acre feet stored water; this permit is issued subject to the terms and conditions of an Agreement recorded in Pages 782-783, Volume 3, Miscellaneous Records of the State Engineer and by reference made a part hereof,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the S $\frac{1}{2}$ SW $\frac{1}{4}$, Section 33, Township 37 South, Range 15 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of of one cubic foot per second per acre, 3.0 acre feet per acre or its equivalent for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed 76.6 acre feet per year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary

3.9 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$

1.2 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$

Section 24

Supplemental

5.5 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

Section 13

25.1 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$

37.8 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$

Section 24

Township 37 South, Range 14 East, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
