**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** SAMUEL A. SHEPARD

of Lacombe, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Crabtree Creek and unnamed stream a tributary of South Santiam River for the purpose of irrigation of 10.5 acres under Permit No. 22066 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 30, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second; Water to be diverted from unnamed stream when available and any deficiency in the available supply in the unnamed stream is to be made up by diversion from Crabtree Creek, providing that the total quantity diverted from both streams shall not exceed 1/80th cubic foot per second for each acre irrigated,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section 20, Township 11 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.5 acres Lot 5 (NW $\frac{1}{4}$  SE $\frac{1}{4}$ )  
Section 20  
Township 11 South, Range 1 East, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a 3/4" pipe on the N. line of Lot 5, which is N. 88°41' W. 24.55 chs. from the  $\frac{1}{4}$  section corner on the E. line of said Sec. 20; th. S. 0° 03' E. 14.439 chs.; th. N. 88°55' W. 15.48 chs. more or less, to the N. & S. center line of Sec. 20; th. N. along said center line 8.36 chs., more or less, to a 3/4" pipe on the S. line of the Joseph Elkins DLC 43; th. N. 89°13' E. along said S. line 11.50 chs. to the SE corner of said Claim; th. N. along the E. line of said Claim 5.721 chs. to a 3/4" pipe at the NW corner of Lot 5; th. S. 88°41' E. along the line 3.95 chs. to the place of beginning; except therefrom that portion lying N. of Crabtree Creek; also, except that part conveyed to Willamette Valley Lumber Co. per 149/565 for road purposes.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
