**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That WILLIAM E. and OMA L. FARRAR**

of P. O. Box 4, Brooks, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well a tributary of Willamette River for the purpose of irrigation of 45.1 acres under Permit No. G-315 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1956,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.45 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SW $\frac{1}{4}$  as projected within L. Brooks DLC #64, Section 17, Township 6 South, Range 2 West, W.M. S. 58° 45' W. 23.836 chs. from the NW corner of Moisen DLC #68,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
 2.0 acres NW $\frac{1}{4}$  SW $\frac{1}{4}$   
 23.1 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$   
 2.4 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$   
 Section 17  
 1.3 acres NE $\frac{1}{4}$  SE $\frac{1}{4}$   
 15.8 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$   
 Section 18

All as projected within L. Brooks DLC #64  
 Township 6 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. on the W'ly line of the R/W of the S.P.R.R. at a point S. 19° W. 8.16 chs. and 14.16 chs. W. of NW cor. of Moisen DLC #68; th. W. 39.22 chs. to E. line of Massey's land as described in Vol. 84, Page 502, Deed Records; th. S. 0°45' E. 12.69 chs.; th. S. 89°30' E. 31.13 chs. to the R/W of the S.P.R.R.; th. N. 31°15' E. on the W. line of said R/W 15.10 chs. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
