**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** ENOS A. and RENA K. POTTS

of 14606 E. Palm Ave., Puente, State of California, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream and reservoir constructed under Appl. No. 16941, Per. No. R-706 a tributary of Winchuck River for the purpose of irrigation of 10.7 acres, domestic use 1 family and stock under Permit No. 12648 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 16, 1937.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot per second; being 0.13 cubic foot per second for irrigation and 0.01 cubic foot per second for domestic and stock,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 23, Township 41 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.1 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
 7.6 acres, domestic and stock Lot 6 (SE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
 Section 23  
 Township 41 South, Range 13 West, W.M.

This certificate is issued to correct and supersede that certain water right certificate issued to Enos A. and Rena K. Potts on June 30, 1950, and recorded in State Record of Water Right Certificates, Volume 14, Page 17390, so as to correctly show the lands irrigated.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
