CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROGER I. and DORIS A. OLIVER

of Box 91, Harbor, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Johnson Creek a tributary of Pacific Ocean for the purpose of irrigation of 5.4 acres under Permit No. 22252 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 13, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Johnson DLC #43, Section 15, Township 41 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
0.3 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
0.6 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$

All as projected within Johnson DLC #43
Section 15
Township 41 South, Range 13 West, W.M.

Land on which water is to be used is part of that described as follows:

A tract of land lying in DLC #43, being in the W $\frac{1}{2}$ of Sec. 15, T. 41 S., R. 13 W., W.M., Curry County, Oregon; beg. at a point which is N. 544.3 ft. and W. 1835.9 ft. from the SE corner of the Robert S. Johnson DLC #43, th. N. 36° 31' E. 95.0 ft.; th. N. 53° 24' W. 636.5 ft.; th. N. 36° 31' E. 410.0 ft.; th. S. 53° 24' E. 526.1 ft. to an iron pipe; th. S. 53° 24' E. 40.0 ft.; more or less, to the thread of the stream of Johnson Creek; th. following said thread of stream southerly to a point which is due E. from the point of beg.; th. W. 40.0 ft., more or less, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
