CERTIFICATE OF WATER RIGHT

This Is to Certify, That LEWIS FRANKLIN GALLIGHER

of Willamina, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Yamhill River a tributary of Willamette River for the purpose of irrigation of 1.6 acres under Permit No. 22397 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 6, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 8, Township 6 South, Range 7 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

0.2 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 9

Township 6 South, Range 7 West, W.M.

Land on which water is to be used is part of that described as follows:

Begin. at an iron pipe which is 64.7 ft. E. and 1121.5 ft. N. of the Sec. corner of Secs. 8, 9, 16 and 17 in T. 6 S., R. 7 W., W.M.; th. running N. 75° 01' W. 208 ft. 8 inches to an iron pipe; th. N. 208 ft. 8 inches to an iron pipe on the S. boundary of the State Highway; th. S. 75° 01' E. 208 ft. 8 inches to an iron pipe; th. S. 208 ft. 8 inches to the place of beginning. ALSO beginning at an iron pipe 64.7 ft. E. and 413.5 ft. N. of the corner to Secs. 8, 9, 16 and 17 in T. 6 S., R. 7 W., W.M.; th. N. 0° 30' W. 916 ft. 8 inches to the S. boundary of State Highway; th. S. 75° 01' E. 125 ft. 7 inches; th. S. 30' E. 884 ft.; th. W. 121 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
