CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRED A. ANDERSON

of Harbor, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Fork Benson Creek a tributary of Chetco River for the purpose of irrigation of 1.8 acres under Permit No. 22523 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 2, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (SE $\frac{1}{4}$ SW $\frac{1}{4}$), Section 4, Township 41 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.8 acres Lot 1 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
 Section 4
 Township 41 South, Range 13 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the SW corner of said Lot 1; th. N. 560.4 ft.; th. N. 80° 00' E. 235.5 ft.; th. N. 76° 57' E. 314.5 ft.; th. S. 21° 00' E. 256.9 ft.; th. S. 61° 55' W. 142.7 ft.; th. W. 272.0 ft.; th. S. 364.9 ft.; th. W. 232.1 ft. to the point of beg. EXCEPTING therefrom a strip of land which is used for road purposes, said strip of land being 8.0 ft. in width lying E. of and parallel and adjacent to the W. boundary line of the above tract. ALSO a tract of land beginning at a point on the center line of Benson Creek (South Fork) said point being N. 770 ft. and W. 1320 ft. from the SE corner of Lot 1 in Sec. 4, T. 41 S., R. 13 W., W.M.; th. S. 102.0 ft. to the N. line of a road; th. along said northerly road line N. 79° 00' E. 400.0 ft.; and continueing N. 62° 00' E. 42.0 ft.; th. N. 42° 00' E. 360.0 ft. to the center line of Benson Creek; th. southwesterly along the center line of Benson Creek to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
