CERTIFICATE OF WATER RIGHT

This Is To Certify, That R. L. NELSON

of Crawfordsville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooia River a tributary of Willamette River for the purpose of irrigation of 29.5 acres under Permit No. 23824 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 18, 1955,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ & SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Riggs DLC #39, Section 7, Township 14 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
6.0 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 7
10.9 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
7.3 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
Section 18

All as projected within Riggs DLC #39
Township 14 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a 1" bolt which bears S. 0° 48' E. 2112.2 ft. from a point on the N. line of and S. 89° 55 $\frac{1}{2}$ ' E. 2805 ft. from the NW cor. of claim 39 in T. 14 S., R. 1 W., said beg. point being on the Northerly right of way of the State Highway; th. S. 80° 33' W. along said right of way 708.30 ft. to a 5/8" iron rod on the E. line of J.B. Keeney (95-244); th. N. 0° 25' W. (old bearing N.) 153.45 ft. to a 3/8" iron rod; th. N. 6° 38' W. 1428.95 ft. to the center line of the Calapooia River; th. N. 58° 44' E. along said center line 357.17 ft.; th. N. 52° 47' E. along said center line 230.28 ft. to a point N. 0° 48' W. 2182.42 ft. & S. 63° 42' W. 387.75 ft. from the place of beginning; th. S. 0° 48' E. 429.0 ft. to an iron bar; th. N. 63° 42' E. 387.75 ft. to a rifle barrel; th. S. 0° 48' E. 1753.42 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
