## CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That F. M. LOCKWOOD.

of Walla Walla, State of Washington, has a right to the use of the waters of EAST BRANCH OF MUD CREEK, a tributary of the Walla Walla River, in Umatilla County, Oregon,

for the purposes of irrigation and domestic use; (Irrigation season: from April lst to September 15th of each year; also wirter irrigation)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 113; that the priority of the right hereby confirmed dates from 1888 for the irrigation of ten acres, from 1890 for the irrigation of forty acres, from 1888 for the irrigation of thirty-five acres, from 1890 for the irrigation of eighty-three acres, and from 1885 for the irrigation of ten acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic feet per second as of date 1888, 0.5 cubic feet per second as of date 1890, 0.88 cubic feet per second as of date 1890, and 0.13 cubic feet per second as of date 1895;

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Ten (10) acres in SW4 of NW4, Sec. 17, T. 6 N. R. 35 E., W. M.; forty (40) acres in SE2 of SE4, Sec. 17, Tp. 6 N., R. 35 E., W. M.; fifteen (15) acres in SW2 of NE4; twenty (20) acres in SE2 of NW2, Sec. 17, T. 6 N., R. 35 E., W. M.; twenty-nine (29) acres in NE4 of SW4; four (4) acres in SE2 of SW4, five (5) acres in NE2 of SE2; forty (40) acres in NW2 of SE2; five (5) acres in SW4 of SE4, Sec. 17, T. 6 N. R. 35 E., W. M.; ten (10) acres in SW4 of SW4, Sec. 16, T. 6 N. R. 35 E., W. M.; in Umatilla County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lunds or place of use herein described.
