John Day River: 1/40 cubic foot per second per acre irrigated from April 1 to Sept. 30; further limited to one acre-foot per acreper calendar month to July 1 and 3/4 acre-foot per acre thereafter; total five acre-feet per acre for season. measured at point of diversion.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
