CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That MAXWELL IRRIGATION COMPANY of Echo State of Oregon has a right to the use of the waters of Umatilla River, a tributary of the Columbia River,

for the purpose of the irrigation of 204 acres of land, domestic and stock use, also municipal and domestic supply for the City of Stanfield, Oregon.

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 127; that the priority of the right hereby confirmed dates from September 11, 1894

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose s, and shall not exceed 2.55 cubic feet per second, subject to the provisions of paragraph 33 of said decree and all other conditions and limitations contained in said decree. 11.5 cubic feet per second being allowed for Municipal and domestic supplies for the City of Stanfield, Oregon.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 13 acres in the Northeast quarter of Northwest quarter; 5 acres in the Northwest quarter of Northwest quarter; 2 acres in the Southwest quarter of Northwest quarter and 8 acres in the Southeast quarter of Northwest quarter of Section Five, Township Three North, Range Twenty-nine; 2 acres in the Northwest quarter of Northeast quarter; 34 acres in the Southwest quarter of Northeast quarter and 20 acres in the Southeast quarter of Northeast quarter of Section Thirty-one Township Four North, Range Twenty-nine; 5 acres in the Southwest quarter of Northwest quarter; 24 acres in the Northeast quarter of Southwest quarter; 2 acres in the Northwest quarter of Southwest quarter; 15 acres in the Southwest quarter of Southwest quarter; 33 acres in the Southeast quarter of Southwest quarter; 20 acres in the Northwest quarter of Southeast quarter and 21 acres in the Southwest quarter of Southeast quarter of Section Thirty-two, Township Four North, Range Twenty-nine East of Willamette Meridian, in Umatilla County, Oregon.
