**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **JOE ZUMPF**

of Harbor, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream a tributary of Pacific Ocean for the purpose of irrigation of 1.7 acres under Permit No. 19081 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 27, 1949,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 16, Township 41 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.3 acres Lot 2 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
 0.4 acres NW $\frac{1}{2}$  NE $\frac{1}{4}$   
 Section 16  
 Township 41 South, Range 13 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at an iron pipe driven at a point 3537.4 ft. S. and 480.3 ft. E. of an iron pipe marking the SE cor. of the James W. Taggart DLC #40; th. N. 3°03' E. 1055.8 ft. to an iron pipe; th. S. 51° 08' E. 328.4 ft. to an iron pipe; th. S. 65° 23' W. 117.8 ft. to an iron pipe; th. S. 8° 05' E. 105.8 ft. to an iron pipe; th. S. 19° 22' E. 390.0 ft. to the center of a creek; th. approximately S. 6° 20' W. down the center of the channel of said creek 250.0 ft., more or less, to the Ordinary High Tide Line of the Pacific Ocean; th. Southwesterly following said Ordinary High Tide Line to a point that bears S. 50° 00' E. from the point of Beg.; th. N. 50° 00' W. 100.0 ft., more or less, to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
