CERTIFICATE OF WATER RIGHT

This Is to Certify, That. LODA M. SKITH

of Box 452, Gold Hill , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean

for the purpose of

irrigation of 1.5 acres under Permit No. 23594 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 27. 1955.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW_{π}^{1} NW_{π}^{1} , Section 22, Township 36 South. Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres SW NA NW Section 22

Township 36 South, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a 3/4" iron pipe located on the northerly right-of-way line of the Pacific Highway, from which the \(\frac{1}{4} \) corner common to Sections 21 & 22 in T. 36 S., R. 3 W., W.M., Jackson County, Oregon, bears S. 770.77 ft. and W. 1008.01 ft., also being on the easterly line of tract designated as Lot 11 described in Vol. 266, Page 466, Deed Records of Jackson County, Ore.; th. N. 22° 55° 00" E. 255.00 ft. to a 3/4" iron pipe; th. continue N. 22° 55° 00" E. 30.51 ft. to the south bank of Rogue River; th. N. 87° 10' 00" E. 157.00 feet along said southerly river bank; thence S. 33.62 ft. to 3/4" iron pipe; thence continue S. 330.00 ft. to 3/4" iron pipe on the northerly right-of-way line of said Pacific Highway; th. N. 79° 53' 00" W. 283.63 ft. along said right-of-way line to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
