## CERTIFICATE OF WATER RIGHT

This Is to Certify, That MANTON A. CARL

Route 1, Hubbard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed drainage ditch & reservoir const. under Appl. No. R-25382, Per. No. R-1584 for the purpose of a tributary of Pudding River irrigation of 56.5 acres,

of the State Engineer, and that said right to the use of said waters under Permit No. 22728 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1950,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NE SE SE), Section 3. Township 5 South. Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1584,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.6 acres SW4 NE4 as projected within J. Purvine DLC #60

13.0 acres SE# NE# as projected within J. Purvine DLC #60

14.9 acres SE NE as projected within A. Dimmick DIC #59

5.2 acres NE SE as projected within J. Purvine DLC #60

12.3 acres NW# SE# as projected within J. Purvine DLC #60

1.2 acres SW SE as projected within J. Purvine DLC #60

0.9 acres SE SE as projected within J. Purvine DLC #60 Section 3

Township 5 South. Range 1 West. W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the SE cor. of Purvine DLC #60, th. W. 15 chs.; th. N. 20 chs.; th. E. 15 chs.; th. S. 20 chs. to the place of beg. Also, beg. at a point 20 chs. N. & 10 chs. W. of the SE cor. of Purvine DIC #60, th. N. 0° 45' E. 20 chs.; th. E.

20 chs.; th. S. 0° 45' W. 20 chs.; th. W. 20 chs. to the place of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
