## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CORBETT MC LEAN

of 3200 SW Childs Rd., Oswego , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River

a tributary of Willamette River irrigation of 4.2 acres.

for the purpose of

under Permit No. 22389 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4. 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_4^1$   $NE_4^1$ , Section 20, Township 2 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.2 acres SW NE NE Section 20
Township 2 South, Range 1 East, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a ½ inch bridge spike in the center line of the Childs Road No. 848 that is N. 1077.74 ft. distant and W. 673.83 ft. distant from an iron pipe located at the SW cor. of the SE¼ NE¾ of Sec. 20; from said beg. point th. along the center line of said road, S. 80° 07' E. 282.58 ft. to a ½ inch bridge spike; th. S. 0° 16' W. 429.43 ft. to a point which is N. 599.82 ft. and W. 397.43 ft. distant from an iron pipe located at the SW cor. of SE¼ NE¾ of said Sec. 20; th. S. 59° 44' E. 236.26 ft. th. S. 52° 09' 30" W. 377.08 ft. to the ordinary high water line of the left bank of the Tualatin River, th. upstream along said water line, N. 34° 39' W. 140.00 ft. and th. N. 66° 02' 30" W. 113.42 ft.; th., leaving said water line, N. 667.45 ft. to the place of beginning of the tract herein described.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
