CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL H. and ANITA F. CLARK

of Route 1, Box 98, Cornelius, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork Dairy Creek and unnamed stream a tributary of Tualatin River for the purpose of irrigation of 46.5 acres,

under Permit No. 23050 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 6, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second; being 0.08 cubic foot per second from unnamed stream and 0.30 cubic foot per second from East Fork Dairy Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, all as projected within Flemming Dobbins DLC #43, Section 26, Township 2 North, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.9 acres Lot 3 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
3.3 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Dobbins DLC #43
16.0 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Dobbins DLC #43
22.2 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Dobbins DLC #43
3.2 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Dobbins DLC #43
0.2 acres Lot 3 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
Section 26
0.1 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Dobbins DLC #43
0.6 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Dobbins DLC #43
Section 27
Township 2 North, Range 3 West, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
