CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. A. IRWIN

of 505 Siskiyou Blvd., Ashland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of Pacific Ocean for the purpose of irrigation of 2.0 acres,

under Permit No. 24702 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 8, 1957.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 17, Township 36 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 17
Township 36 South, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows:

Commencing at a point 30 ft. N. & 500 ft. W. of the SE cor. of Sec. 17, T. 36 S., R. 3 W., W.M., Jackson County, Oregon, for the true point of beginning; th. E., and parallel with the S. line of said Section, 200 ft.; th. N. to Rogue River (said point being on the northerly line of tract described in Volume 203, Page 66 of the Deed Records of Jackson County, Oregon); th. Northwesterly along the River and the northerly line of said tract, to a point due N. of the point of beginning; th. S. 460.7 ft., more or less, to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
