CERTIFICATE OF WATER RIGHT

This Is to Certify, That ELLIOTT and MILDENE WOOLDRIDGE

of Box 240, Azalea, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Nidey Branch a tributary of Cow Creek for the purpose of irrigation of 0.7 acres,

under Permit No. 22838 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 19, 1954,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 14, Township 32 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $3\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 14
Township 32 South, Range 5 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a point on the W. boundary of the former Pacific Highway which bears S. 29° 17' W. 875.6 ft. from the $\frac{1}{4}$ corner on the S. boundary of Section 11, T. 32 S., R. 5 W., W.M.; th. N. 42° 13' W. 305.4 ft.; th. S. 41° 49' W. 150.0 ft.; th. S. 38° 44' E. 315.9 ft. to W. boundary of former Pacific Highway; th. following said W. boundary of former Pacific Highway N. 39° 10' E. 170.2 ft. to the place of beg. containing 1.13 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
