**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** JOHN and MARIAN RAK

of Route 3, Box 179, Newberg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream & reservoir constructed under Appl. No. R-31964, Per. No. R-2090 a tributary of Chehalem Creek for the purpose of irrigation of 7.6 acres,

under Permit No. 25190 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1957,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.1 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within M. Hall DLC #72, Section 23, Township 3 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2090,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
0.6 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
1.6 acres SW $\frac{1}{4}$  NE $\frac{1}{4}$   
4.4 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$

All as projected within M. Hall DLC #72  
Section 23  
Township 3 South, Range 3 West, W. M.

Land on which water is to be used is part of that described as follows:

beg. at a point 7.15 chs. S. of the SE cor. of the original DLC of John Williamson and Susan O. Williamson, his wife, Claim No. 46 in said T. & R. and running th. S. 1° 25' E. 12.64 chs. th. E. 13.68 chs.; th. N. 12.64 chs.; th. W. 14.00 chs. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
