CERTIFICATE OF WATER RIGHT

This Is to Certify, That HOWARD L. CROFF

of Route 2. Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mary's River a tributary of Willamette River for the purpose of irrigation of 29.9 acres.

under Permit No. 19054 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 25. 1949.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SWT as projected within Allen DLC #55. Section 16. Township 12 South. Range 5 West. W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.2 acres NEL SWA

11.0 acres NW: SW: 6.9 acres SW: SW:

5.8 acres SE SW

All as projected within Allen DLC #55 Section 16

Township 12 South, Range 5 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a one inch pipe, which is on the division line between the E. & W. half of the Hiram Allen DIC #55, th. N. 1 ch., more or less to the center of Mary's river, th. following the meanderings of said river to a point 1 ch. more or less E. of a stake, said stake being 640 ft. S. of a 1" pipe (which is 1.06 ch. N. 77°27' W. of the center of Mary's river, said pipe being on the dividing line between the Hiram Allen DIC #55 & the old O. L. Davis land rem owned by H. L. Watenpaugh), th. running N. 77°27' W. 30 chs. along the division line between the H. L. Watenpaugh and H. L. Croff Farms to a stake, th. S. 14 chs. to a stake on the division line between the H. L. Croff farm and the O. G. Roberts farm, th. N. 89°52' E. (following said division line) for 30 chs. more or less to point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
