CERTIFICATE OF WATER RIGHT

This Is to Certify, That DALE H. FOORD

of Route 1, Box 375, North Bend, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek a tributary of Coos Bay for the purpose of Irrigation of 0.99 acres.

under Permit No. 19991 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 20, 1950.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 35, Township 24 South, Range 13 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.99 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 35
Township 24 South, Range 13 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at an Iron Pipe located 1587.71' N. & 223.25' E. of the S $\frac{1}{4}$ cor., Sec. 35, T. 24 S., R. 13 W., W.M.; th. N. 22° 59' W. 956.9' to an iron pipe on the S. line of the Oregon Coast Highway; th. N. 67° 01' E. along said S. line of the Oregon Coast Highway 250 ft. to an Iron Pipe; th. S. 22° 59' E. a distance of 956.9' to an Iron Pipe; th. S. 67° 01' W. a distance of 250 ft. to the point of beg.; Containing 5.50 acres more or less and being a portion of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ and Government Lot 2 of Sec. 35, T. 24 S., R. 13 W., W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
