CERTIFICATE OF WATER RIGHT

This Is to Certify, That OSCAR and OREN WEED

of Vernonia, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Nehalem River a tributary of Pacific Ocean for the purpose of irrigation of 30.9 acres,

under Permit No. 21695 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 11, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 12, Township 4 North, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

30.1 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
 0.8 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
 Section 12
 Township 4 North, Range 5 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the SW cor. of Sec. 12, T. 4 N., R. 5 W., W.M., th. on a variation of 22° 30' running N. 40.9 chs. to the $\frac{1}{4}$ cor.; th. S. 89° 38' E. 53.84 chs. to agreed upon center of Sec.; th. S. 18° 33' W. 42.9 chs. to the S. $\frac{1}{4}$ cor. of said Sec. 12; th. W. on the Sec. line to point of beg.

This certificate is issued to correct and supersede that certain water right certificate issued on July 12, 1957, and recorded in State Record of Water Right Certificates, Volume 16, Page 22968, so as to correctly show the lands irrigated.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
