CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEO. H. and BLANCHE F. ROWLETT

of Route 1, Box 24, Aurora, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Senechal Creek a tributary of Mill Creek for the purpose of irrigation of 14.0 acres,

under Permit No. 21951 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 19, 1952,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ and NW $\frac{1}{4}$ as projected within Grim DLC #46, Section 15, Township 4 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.8 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 10
7.2 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 15
Both as projected within Grim DLC #46
Township 4 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at an iron bar 26 inches long set in the E. boundary of the Jacob Grim DLC #46, and which said bar is 10 chs. N. of the SE cor. of said Jacob Grim DLC.; running th. W. 15.00 chs. to an iron bar 26 in. long set in the ground; th. N. 18.12 chs. to an iron bar 26 in. long set in the Country road leading from Champoeg to Aurora; th. N. 74° 40' E. along said road 9.71 chs.; th. E. 5.60 chs. to an iron bar 26 in. long set in the E. boundary of said Jacob Grim DLC; th. S. 20.67 chs. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
