CERTIFICATE OF WATER RIGHT

This Is to Certify, That Y. M. MC GILL

of Route 1, Box 117, Turner, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Santiam River a tributary of Willamette River for the purpose of irrigation of 35.1 acres,

under Permit No. 22150 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 25, 1953,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.06 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE¹/₄, NE¹/₄ & SW¹/₄, NE¹/₄, both as projected within Chamness DLC #59, Section 34, Township 9 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2¹/₂ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.2 acres NW¹/₄ NE¹/₄

All as projected within Chamness DLC #59
Township 9 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:
Beg. on the E. boundary line of Isreal Chamness DLC #59; said point being S. 24.35 chs. from the NE cor. of said DLC and in the center line of the co. road from Marion to Stayton, th. S. 43.03 chs.; th. W. 3.50 chs.; th. S. 67° 00' W. 3.00 chs.; th. N. 57° W. 1.79 chs.; th. S. 68° 30' W. 4.64 chs.; th. S. 45° W. 3.00 chs.; th. S. 55° W. 5.62 chs.; th. S. 38° 30' W. 2.84 chs.; th. S. 6° 30' E. 5.00 chs.; th. S. 70° 00' E. 12.70 chs.; to the SE boundary line of said claim. Th. S. 45° W. 3.00 chs. to the most southerly SE cor. of said DLC; th. W. 21.89 chs. to a point which is S. 88.38 chs. and W. 32.25 chs. from the NE cor. of said claim, th. N. 46.65 chs. to iron pipe center line of said road which is S. 41.73 chs. from N. boundary of said claim, th. N. 62° E. along center of county road 36.78 chs. to point of beg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
