a tributary of Willamette River irrigation of 1.8 acres.

of the State Engineer, and that said right to the use of said waters under Permit No. 22345 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 7, 1952.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL as projected within E. Kellogg DIC #54. Section 6, Township 2 South, Range 2 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres NEt NEt .4 acres SE NE Both as projected within E. Kellogg DLC #54 Section 6 Township 2 South, Range 2 East, W.M.

Land on which water is to be used is part of that described as follows: Beg. at the NE cor. of that certain tract of land conveyed to H. Holman and Ethel A. Gray, which point is N. 89° 18' W. 679.40 ft. distant from the NE cor. of Kellogg DLC #54; running th. S. 0° 10' W. tracing the E. boundary of said Gray tract 535.00 ft. to a point in the center of Kellogg Creek; th. along the center of said creek downstream N. 58° 29' W. 23.42 ft.; th. tracing the center of said creek downstream S. 87° 26' W. 210.23 ft. to a point on the W. boundary of the land of H. Holman Gray and wife, bears N. 0° 10' E. 30.00 ft. distant; th. N. 0° 10' E. tracing the W. boundary of the Gray's land 535.00 ft. to an iron pipe driven at the NW cor. of the Gray's land; th. tracing the N. boundary of the Kellogg DLC aforesaid S. 89° 18' E. 230.00 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
