CERTIFICATE OF WATER RIGHT

This Is to Certify, That **PACIFIC POWER & LIGHT COMPANY**

of Public Service Building, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork of Wallowa River a tributary of Wallowa River for the purpose of Power

under Permit Nos. 4595-5401 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Feb. 16, 1920 for 12 second feet under permit No. 4595 and April 5, 1922 for 3 second feet under permit No. 5401; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes; and shall not exceed 15.00 cubic feet per second.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

(The right herein described shall be limited to the development of 2,000 theoretical horsepower, utilizing a fall of 1173 feet)

Note: This certificate is issued pursuant to the provisions of ORS 537.290, and supercedes certificate recorded at Page 3923, Volume 5, State Record of Water Right Certificates, and recorded at Page 59, Volume 1, Book of Water Right Certificates, Wallowa County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.

After the expiration of fifty years from the date of this certificate or on the expiration of any federal power license issued in connection with this right, and after not less than two years' notice in writing to the holder hereof, the State of Oregon, or any municipality thereof, shall have the right to take over the dams, plants and other structures and all appurtenances thereto which have been constructed for the purpose of devoting to beneficial use the water rights specified herein, upon condition that before taking possession the State or municipality shall pay not to exceed the fair value of the property so taken, plus such reasonable damages, if any, to valuable, serviceable and dependable property of the holder of this certificate, not taken over, as may be caused by the severance therefrom of the property taken in accordance with the provisions of ~~section 45-500, Oregon Code 1930~~ ORS 537.290.
