**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** GALE G. WERNER

of Route 3, Box 119, Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaver Creek a tributary of Crabtree Creek for the purpose of irrigation of 20.0 acres,

under Permit No. 20031 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 5, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$  as projected within Gregg DLC 44, Section 17, Township 11 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.0 acres SW $\frac{1}{4}$  SW $\frac{1}{4}$

3.4 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$

Section 17

3.8 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$

3.8 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$

Section 20

All as projected within Gregg DLC 44  
Township 11 South, Range 1 West, W.M.

Land on which water is to be used is part of that described as follows: Beginning at the interior corner of Griggs DLC 44; thence West 13.25 chains to the West boundary line of a tract heretofore conveyed to Fred Freese; thence North 27.90 chains to the center of the main channel of Beaver Creek; thence Southeasterly along said center line to an intersection with the East line of the Northerly projection of said Claim #44; thence South along said East line 12 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
