that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.35 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4 as projected within Ritner DLC #58. Section 5, Township 10 South, Range 6 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres NE SE as projected within Sebastian P. Ritner DLC #58 7.2 acres Nw SE as projected within Sebastian P. Ritner DLC #58

18.4 acres NW4 SE4 as projected within Sarah Ritner DLC #59 0.2 acres SW4 SE4 as projected within Sarah Ritner DLC #59

0.6 acres SM SE as projected within Sebastian P. Ritner DLC #58 Section 5

Township 10 South, Range 6 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at an anchor post on the N. side of the Kerber road at 23.48 chs. N. of the ½ cor. on the S. of Sec. 5; th. N. 18 chs. to the center of Ritner Creek; th. down said creek to the W. boundary of the county road now state highway; th. along the W. boundary of highway S. 13° 5' E. 3.00 chs. th. N. 82° 45' W. 3.99 chs. to fence corner on N. side of Kerber road; th. S. 28° 20' W. 6.78 chs. to fence corner on N. of said road; th. N. 66° 30' W. 12.00 chs. along the N. of road; th. N. 71° 15' W. 4.50 chs.; th. N. 88° W. 3.75 chs. to the place of beginning.
