CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN L. SPARKS

of Route 1, Box 155, Independence, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Luckiamute River a tributary of Willamette River for the purpose of irrigation of 10.4 acres,

under Permit No. 20830 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 26, 1951,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Vanderpool DLC #63, Section 20, Township 9 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.6 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
7.8 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
All as projected within Vanderpool DLC #63
Section 20
Township 9 South, Range 4 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a point 60 ft. W. and 20 ft. S. of the SW cor. of Lot 8, Block 1 as the same is laid down and numbered on the plat of the town of Parker in the County of Polk and State of Oregon; th. N. 1° 56' W. 9.40 chs. to a point 60 ft. W. of the SW cor. of Lot 8 in Block No. 3 of the town of Parker; th. N. 28° W. 2.33 chs. to a stone in the center of the road; th. N. 19° W. 36 links to the NE cor. of this tract, th. S. 74° 30' W. 22.28 chs.; th. S. 7° W. 505 chs. to the SW cor. of the Vanderpool land claim th. E. 24.50 chs. to the place of beginning containing 19.74 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
