CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That M. S. CORRIGAL
of Echo State of Oregon, has a right to the use of
the waters of Butter Creek Springs, tributary of the Umatilla River,

for the purpose of the irrigation of 178.1 acres of land, domestic and stock use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 250; that the priority of the right hereby confirmed dates from 1884 for 1.35 cubic feet per second; 1895 for 1.17 cubic feet per second, and 1904 for 1.11 cubic feet per second;

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 3.61 cubic feet per second, and shall be subject to all other conditions and limitations contained in said decree.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 40 acres in the Northeast quarter of Northeast quarter; 8.5 acres in the Northwest quarter of Northeast quarter; 14.3 acres in the Southwest quarter of Northeast quarter; 40 acres in the Southeast quarter of Northeast quarter of Section Twenty-eight; 2.5 acres in the Northeast quarter of Southeast quarter; 28.5 acres in the Southeast quarter of Southeast quarter of Section Twenty-one, Township Two North, Range Twenty-seven East of Willamette Meridian, in Morrow County, Oregon.

2.5 acres in the Northeast quarter of Southwest quarter; 21.4 acres in the Southeast quarter of Southwest quarter of Section Fifteen, Township Two North, Range Twenty-seven and 20.4 acres in the Southwest quarter of Northwest quarter of Section Twenty-five, Township Three North, Range Twenty-seven, all East of Willamette Meridian, in Umatilla County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
