CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT H. and CHRISTINA GENTNER

of Route 3. Box 153½ C. Letanon , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Springs Nos. 1, 2 and 3 a tributary of Crabtree Creek for the purpose of domestic use 1 family and irrigation of 2.2 acres.

under Permit No. 22710 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 30. 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second; being 0.01 cubic foot per second from Spring No. 1 for domestic and 0.02 cubic foot per second from Spring No. 2 and 0.01 cubic foot per second from Spring No. 3 for irrigation.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Springs 1 and 2, NE SW. Spring 3, NW SW. Section 21, Township 11 South, Range 1 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conjurm to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.8 acres $NE_{+}^{L} SW_{+}^{L}$ 0.4 acres $NW_{+}^{L} SW_{+}^{L}$ Section 21 Township 11 South, Range 1 East, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the SW cor. of the \mathbb{E}_2^1 of the \mathbb{N}_4^1 SW $_4^1$, Sec. 21, T. 11 S., R. 1 E., W.M., Linn County, Oregon, and running th. E. along the S. line of the \mathbb{N}_2^1 SW $_4^1$ of said Sec. 21, a distance of 1190 ft.; th. N. 720 ft., more or less, to the S. line of that certain right of way conveyed to Willamette Valley Lumber Company and described on Page 529 of Volume 141, Linn County Deed Records; th. Westerly along said right of way to the W. line of the \mathbb{E}_2^1 of the \mathbb{N}_4^1 of said Sec. 21; th. S. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
