**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** WALTER J. ROSENFELD

of 1717 S. W. Park Avenue, Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Clackamas River for the purpose of Irrigation of 3.64 acres,

under Permit No. 24384 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1956,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 6 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 15, Township 2 South, Range 2 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre Lot 6 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
0.4 acre NE $\frac{1}{4}$  SW $\frac{1}{4}$   
0.8 acre Lot 7 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
1.94 acre Lot 7 (NW $\frac{1}{4}$  SE $\frac{1}{4}$ )

Section 15

Township 2 South, Range 2 East, W.M.

Land on which water is to be used is part of that described as follows: Beginning at a point in the division line of the Hezekiah Johnson DLG in the center of Clackamas Co. Market Rd. 28 that bears N. 0°5'55" E. 1193.46 ft. distant from a point that bears N. 1222.29 ft. N. and 88.55 ft. W. of the  $\frac{1}{4}$  Sec. cor. between Sec. 15 and 22, T.2S., R.2E., W.M., running th. N. 0°5'55" E. 455.25 ft. to an iron pipe; th. south 55°00' E. 520.25 ft. to an iron pipe; th. S. 35° 26' W. 136.31 feet to an iron pipe; th. S. 36°51'16" W. 96.42 ft. to an iron pipe; th. S. 16°16' W. 91.90 ft. to an iron pipe; th. S. 26°56' W. 41.3 ft. to the center line of said Market Rd. 28; th. tracing the center line of said Market Rd. No. 28, N.W. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
