This Is to Certify, That HENRY DINGES

of Route 1, Box 476, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of one well

a tributary of Willamette River irrigation of 14 acres

for the purpose of

under Permit No. G-130 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 20, 1956

that the amount of water to which such right is crititled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWW. SWM as projected within L. Vandall DLC 64, Section 2, Township 5 South, Range 2 West, W.M., 1275 feet North and 1450 feet West from South West corner of DLC 64.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre NE% SW% 12.9 acres NW% SW% Section 2 1.0 acre NE% SE% Section 3

All as projected within L. Vandall DLC 64 Township 5 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows: Beginning at a point on the West line of the Vandall DLC 64, 1739 feet N. 23°25' E. from the SW corner thereof; running th. S. 66°30' E. parallel with the division said D.L.C. into the N. and S. halves, 1551 feet; th. N. 23°25' E. parallel with the W. parallel with the W. line of said claim 412.5 ft.; more or less, to the SE corner of Allen Proctor's tract of land said point being 412.5 ft. from the division line; th. N. 66°30' W. along the S. line of said Proctor's land, 1584 ft. to the SW corner of said Proctor's tract; th. S. 23°25' W. 412.5 ft., to pt. 33 ft. N. 66°30' W. of the place of beg. th. S. 66°30' E. 33 ft. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
