This Is to Certify, That WILSON A. and CORRINE V. ETTINGER

of 4020 SW 247 Ave.. Hillsboro , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed creek & res. const. under Appl. No. R-28717. Per. No. R-1570 a tributary of Tualatin River for the purpose of primary irrigation of 26.6 acres and supplemental irrigation of 27.6 acres.

under Permit No. 2264? of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 18, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second from direct flow and 56 acre feet stored water.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE NE 4 as projected within Stewart DLC #56. Section 16. Township 1 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1570 and shall be further limited to the use of stored water only on lands described as supplemental,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
