CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIS N. and STELLA J. NYBERG

of **Crawfordsville**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of **Brush Creek** a tributary of **Calapooia River** for the purpose of **irrigation of 33.6 acres,**

under Permit No. **23277** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **November 15, 1954,**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.42 cubic foot per second,**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$** as projected within **Woodfin DLC 43, Section 20, Township 14 South, Range 1 West, W.M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$ acre feet** per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

**3.6 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
11.4 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
18.6 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$**

Section 20

**All as projected within Woodfin DLC 43,
Township 14 South, Range 1 West, W.M.**

Land on which water is to be used is part of that described as follows: Beginning at a point on the East line of Woodfin DLC 43 which is 36.63 chains distant from the Southeast corner of said DLC; and running thence S. 80° West and parallel to the S. line of said claim, 44.88 chains to a point which is N. 80° E. 27.94 chains distant and N. 6°15' W. 36.63 chains distant from the extreme S. corner of said claim; thence N. 6°15' W. and parallel to the East line of said claim 10.78 chains; thence N. 80° E. parallel to the S. line of said claim 44.88 chains to the E. line of said claim; thence S. 6°15' E. on the E. line of said claim 10.78 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
