CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That CLOVERDALE IRRIGATION COMPANY, a corporation, of State of Oregon has a right to the use of the waters of SQUAW CREEK, a tributary of the Deschutes River, in Crook County, Oregon,

for the purpose of irrigation and domestic use, (irrigation during the irrigation season)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 120 ; that the priority of the right hereby confirmed dates from Dec. 6, 1903;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.45 cubic feet per second.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

30 acres in NE 1/4 of SE 1/4; 9 acres in NW 1/4 of SE 1/4; 8 acres in SW 1/4 of SE 1/4; and 24 acres in SE 1/4 of SE 1/4; Sec. 6, Tp. 15 S. R. 11 E., W. M.; 2 acres in NE 1/4 of NW 1/4; 3 acres in NW 1/4 of NW 1/4; 3 acres in SW 1/4 of NW 1/4; and 1 1/2 acres in SE 1/4 of NW 1/4; Sec. 14, Tp. 15 S. R. 10 E., W. M.; 1 1/2 acres in NW 1/4 of SW 1/4; 30 1/2 acres in SW 1/4 of SW 1/4; Sec. 31; and 2 1/2 acres in NE 1/4 of SE 1/4; 4 1/2 acres in SE 1/4 of SE 1/4; Sec. 36, Tp. 14 S. R. 10 E., W. M.; 40 acres in NE 1/4 of NE 1/4; 5 1/2 acres in NW 1/4 of NE 1/4; 23 acres in SW 1/4 of NE 1/4; 39 acres in SE 1/4 of NE 1/4; 8 acres in NW 1/4 of NW 1/4; 9 acres in SW 1/4 of NW 1/4; and 18 1/2 acres in SE 1/4 of NW 1/4; Sec. 6, Tp. 15 S. R. 11 E., W. M.; all in Crook County, Oregon.
