CERTIFICATE OF WATER RIGHT

This Is to Certify, That FARM DEVELOPMENT CO.

of Riley, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Upper Rock Quarry Canyon & res. const. under Appl. No. R-22980, Per. No. E-936 a tributary of Silver Creek for the purpose of supplemental irrigation of 174.0 acres,

under Permit No. 18281 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 8, 1943,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.50 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 25; SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 27, Township 23 South, Range 27 East, W.M.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-sixtieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated prior to April 30, of each year and one-eightieth of one cubic foot per second or its equivalent for each acre irrigated during the remainder of the irrigation season from direct flow, provided that the total quantity diverted during the months of March, April, May and June shall not exceed 2.5 acre feet per acre for each acre irrigated from direct flow and storage from reservoir constructed under Permit No. R-936,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.2 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
4.0 acres NW $\frac{1}{4}$ NW $\frac{1}{4}$
34.4 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
25.4 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
31.6 acres NE $\frac{1}{4}$ SW $\frac{1}{4}$
40.0 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
15.4 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$
16.0 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$

Township 23 South, Range 27 East, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
