

## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That G. W. SPENCE

of Route 2. Box 92 M. LaGrande , State of Cregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream & Spence Res. const. under Appl. No. R-29057. Per. No. R-1630 a tributary of Grande Ronde River for the purpose of primary irrigation of 3.5 acres and supplemental irrigation of 10.3 acres and fish culture.

under Permit No. 22973 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 11. 1954.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 24.7 acre feet stored water and 0.11 cubic foot per second from direct flow; being 0.09 cubic foot per second for irrigation and 0.02 cubic foot per second for fish.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SE_4^{\frac{1}{4}}$   $NN_4^{\frac{1}{4}}$ . Section 17. Township 3 South, Range 38 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1630 and shall be still further limited to the use of stored water only on the lands described as supplemental and still further limited to a total diversion of 24.7 acre feet of stored water during the irrigation season.

conform to such trasposable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as Joseph series:
