CERTIFICATE OF WATER RIGHT

This Is to Certify, That BOISE CASCADE CORPORATION, MOUNT EMILY DIVISION

of La Grande , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two wells a tributary of Grande Ronde River, tributary of Snake River for the purpose of industrial (saw mill).

under Permit No.G-920 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 3. 1958.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_u^1 NE_u^1 & NE_u^1 NE_u^1 , Section 5, Township 3 South, Range 38 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _ _ _ _ _ _ _ _ _ _ _ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
