a tributary of Tule Lake for the purpose of irrigation of 310.8 acres.

under Permit No. U-457 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 28, 1952 for 3.12 cubic feet per second and July 7, 1952 for 0.76 cubic foot per second,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.88 cubic feet per second; being 2.73 cubic feet per second from Well #1 and 1.15 cubic feet per second from Well #2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a divers on of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year.
