under Permit No. 19163 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from December 9, 1948 for direct flow, December 16, 1930 for 758
acre feet December 9, 1948 for 380.6 acre feet, and November 8, 1949 for 64.1 i.f.
that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
6.24 cubic foot per second from Bendier Creek and 1202.7 acre feet stored water

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWA NEW, Section 36, Township 18 South, Range 37 East; and NEW SEW, Section 19, Township 18 South, Range 38 East, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fourtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season from direct flow and storage from reservoir constructed under Permit No. R-1005,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
