**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** ALBERT BYRON ROSS

of Route 1 Box 40 Bonanza, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well #1 a tributary of Sprague River for the purpose of irrigation of 159.4 acres,

under Permit No. G-491 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 5, 1957.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.99 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 8, Township 36 South, Range 12 East, W.M., 20 feet S. and 50 feet W. of NW cor. of Section 8,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20.0 acres Lot 3 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 6 (NE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 4 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 5 (NW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 12 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
19.4 acres Lot 13 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 11 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ )  
20.0 acres Lot 14 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ )

Township 36 South, Range 12 East, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
