CERTIFICATE OF WATER RIGHT

This Is to Certify, That EARL O. CHRISTOPHERSON

of Route 4, Box 324, Sherwood , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Baker Crack a tributary of Tualatin River

irrigation of 21.4 acres,

for the purpose of

under Permit No. 22246 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 13, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second,

cr its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (SW. N.K.), Section 15, Township 2 South, Range 2 Vest, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 3.2 acres Let 4 (SW/ NW/) 18.2 acres SE% NWA Section 15 Township 2 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows: Commencing at a stake on the W. line of Peter C. Swank DLC in Sec. 15, T.25., R.2W., W."., said point being N. 1°8' E. 9.97% chs. from the SW corner of said Swank claim, th. S. 89°50' W. 25 chs., more or less, to the center of Baker Creek, th. down the center of said creek to the SW cor. of a tract of land conveyed by Sarah A. Cummings to C.D. Weichman by deed recorded on pg. 272, book 52 of deeds for Washington County, Oregon, being also the tract of land conveyed to said Sarah A. Cummings in Deed Book 33, pg. 17; th. N. 89°23' E. 20.11 chs. on the S. line of said Weichman tract to a stone on the W. line of said Peter C. Swank claim, th. S. 1°8' W. 9.97% chs. on said W. line to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
