CERTIFICATE OF WATER RIGHT

This Is to Certify, That DOUGLAS V. HANBY & ARNOLD W. BUCKENDAHL

of Route 1, Box 594, Cave Junction, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of East Fork Illinois River for the purpose of irrigation of 18 acres, and supplemental irrigation of 5.4 acres,

under Permit No. 21636 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 24, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$, SE $\frac{1}{4}$ as projected within Sutherlin DLC 44, Section 23, Township 40 South, Range 8 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{3}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary

12.4 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within W. Sutherlin DLC 44
0.4 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within W. Sutherlin DLC 44
5.2 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within W. Sutherlin DLC 44

Supplemental

1.0 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within J. Lowery DLC 43
4.4 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within J. Lowery DLC 43
Section 23
Township 40 South, Range 8 West, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
