**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That CHARLIE A. HAYNES**

of Route 2 Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McFee Creek a tributary of Tualatin River for the purpose of irrigation of 0.7 acres.

under Permit No. 24632 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 20, 1956.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Rowell DLC 44, Section 16, Township 2 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.25 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$

Section 15

0.45 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$

Section 16

Both as projected within Rowell DLC 44  
Township 2 South, Range 2 West, W.M.

Land on which water is to be used is part of that described as follows:

Begin at an iron pipe on the S. boundary of that certain 33.23 acre tract in the said Rowell DLC conveyed to Phebe A. McCool by deed recorded at page 404 of Book 140 of the records of deeds for Washington County, Oregon, said beginning point being S. 84° 38' E. 253.2 ft. from a stone corner of said McCool lands, said corner being the most westerly angular corner on said S. boundary McCool lands, running thence along said S. boundary of said McCool lands S. 84° 38' E. 211.3 ft. to a point in the approximate center of County Road, thence N. 31° 05' E. along the approximate center of said road a distance of 124.0 ft. thence N. 58° 55' W. 30.0 ft. to an iron pipe; thence continuing N. 53° 55' W. 161.9 ft. to an iron pipe; thence S 31° 05' E. 216.4 ft. to the place of beginning, containing 0.25 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
