CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. A. & LOIS G. CARPENTER

of Route 2 Box 396, Albany, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Carpenter Well #1 a tributary of unnamed slough, tributary of Willamette River for the purpose of irrigation of 26.0 acres,

under Permit No. G-542 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 30, 1957,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Miller Jr. DLC 68, Section 9, Township 10 South, Range 3 West, W.M. S. 0° 45' E. 42.33 chs. from NW cor., Section 9,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres SW $\frac{1}{4}$ NW $\frac{1}{4}$
16.0 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$
Both as projected within Miller Jr. DLC 68
Section 9
Township 10 South, Range 3 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at the $\frac{1}{4}$ section corner between sections 8 & 9 in Township 10 South, Range 3 West of the W.M. in Linn County, Oregon, and running thence S. along said section line 16.25 chs. to the center of a slough; thence S. 60° 15' E. following the center of said slough 11.25 chs.; thence N. 24.24 chs.; thence E. 6.05 chs. to the center of a County Road; thence N. 35° 45' W. along the center of said road 12.03 chs.; thence W. 9.10 chs. to the line between said sections 8 & 9; thence S. 12.25 chs. to the place of beginning., containing 32.85 acres, more or less, except 4.85 acres in the NE corner thereof; leaving 28 acres, more or less, all in Linn County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
