CERTIFICATE OF WATER RIGHT

This Is to Certify, That MERL WATTS, JR.

of 1012 W. 8th St., Eugene, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well a tributary of Willamette River for the purpose of irrigation of 22.4 acres

under Permit No. G-625 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 9, 1957,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within Hulings DLC 49. Section 22, Township 16 South, Range 4 West, W.M. 6 $\frac{1}{2}$ chs. N. & 26 chs. W. from SE cor., DLC 49,

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$
0.8 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 15
2.8 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
15.8 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 22

All as projected within Hulings DLC 49
Township 16 South, Range 4 West, W.M.

Land on which water is to be used is part of that described as follows:

Beg. at a point on S. line of Lester Huling DLC 49, 18.86 chs. W. of SE cor. thereof & running thence W. 13.64 chs. to center of Eugene-Junction City secondary State Highway (formerly county road #200) thence N. 17° 30' W. along center of said highway 13.63 chs; thence E. 20.66 chs. to middle of a certain slough; thence upstream along middle of said slough S. 4° 50' E. 0.19 chs; thence S 6° 01' E. 2.80 chs; thence S. 35° 33' E. 5.60 chs; thence leaving said slough W. 8.23 chs; thence S. 17° 42' E. 5.74 chs. to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
