**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** C. K. & U. M. BARCLAY

of Waldport, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek, locally known as Line Creek a tributary of Alsea River for the purpose of domestic use 1 family including irrigation of  $\frac{1}{2}$  acre lawn & garden, under Permit No. 22813 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 25, 1953.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 34, Township 13 South, Range 10 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

domestic, Lot 5 (NE $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 34  
Township 13 South, Range 10 West, W.M.

Land on which water is to be used is part of that described as follows:  
Beg. at a point that is N. 2597.0 ft. & W. 262.6 ft. from the S $\frac{1}{4}$  cor. Sec. 34, Township 13 South, Range 10 West, W.M. in Lincoln County, Oregon; running thence S. 4° 15' W. 400 ft. to Line Creek, thence along Line Creek as follows: S. 84° 41' W. 57.6 ft. S. 71° 03' W. 60.85 ft., N. 86° 44' W. 85.4 ft. N. 60° 30' W. 68.25 ft; & continuing N. 60° 30' W. 15 ft. more or less to the easterly bank of the Alsea River; thence Northwesterly along the easterly bank of said river to a point that is N. 85° 45' E. 172.7 ft. from the place of beginning; & thence S. 85° 45' E. to the place of beginning; all in U.S. Lot 5, Section 34, Township 13 South, Range 10 West, W.M., in Lincoln County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
