CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. D. LAMB

of Route 1 Box 438 Warrenton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Neahcoxie Creek a tributary of Skipanon River for the purpose of irrigation of 23.7 acres,

under Permit No. 23181 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 3, 1954,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Thompson DLC 45, Section 9, Township 7 North, Range 10 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Thompson DLC 45
0.5 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Thompson DLC 45
Section 4
0.9 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Thompson DLC 45
4.6 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Hudson DLC 44
5.1 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Hudson DLC 44
2.6 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within Thompson DLC 45
Section 9
Township 7 North, Range 10 West, W.M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
